Speaker outlines BMV changes in driver's licenses

On July 2, changes were made in the procedures on obtaining a driver's license. The changes were made to comply with federal regulations and ensure greater security and identification protection, said our September Chamber luncheon speaker, Aldo Filippelli, Deputy Registrar at the North Royalton BMV.

In the past, if one was renewing a license, they would bring in their old license, take an eye test, get their picture taken, answer a few questions and leave with a brand new license. The only change now in that scenario is that the license will not be available at that time, but will be mailed, usually within ten days. A temporary license will be issued at the time of the transaction at Deputy Registrar offices. This measure will allow the state to provide a single location that will produce both driver's licenses and identification cards.

Another thing that changed on July 2 is that residents will have an option to have either a standard Ohio Driver's License/ Identification (ID) Card or a REAL ID Driver's License. The latter will allow drivers to use their driver's license as identification for situations like boarding an airplane.

Starting on October 1, 2020, the federal government will require your driver's license or identification (ID) card to be REAL ID compliant if you wish to use it to board a domestic flight or enter military bases and most federal facilities. Without a REAL ID, people will need a passport as identification in order to board a domestic flight or enter military bases and most federal facilities.

Secure driver's licenses and identification documents are an important part of our national security. The REAL ID Act established security standards for license issuance and production and prohibits Federal Agencies from accepting for certain purposes driver's licenses and identification cards from states not meeting the Act's minimum standards.

In order to get the REAL ID Driver's

License, the following must be provided at the time of applying for a new or renewed license/ ID:

-Identification that establishes name, date of birth and legal presence (such as a birth certificate, US Passport.)

-Proof of social security number (Such as Social Security card).

-Two proofs of address (Such as utility or bank statements/bills or other bills).

The luncheon was very informative and luncheon attendees had many questions for Filippelli.
